### **Community Forum for Cree**

Cree and Alice had a meeting with MVCC and MV Edge and spoke about getting recording into the schools as part of a class.

Cree is getting good response to jobs but also having a challenge in fining people willing to drive to Albany until the jobs are local. Cree is looking for 58 new employees by next 9 months.

### **Report on Remington services & status**

Karin Piseck in Herkimer has been working with Remington employees. Almost 200 are in school looking to pursue Cree classes at MVCC. MVCC & Herkimer has been giving extra help since many of these people are not traditional students, need help with online learning. Funding for the training through the Trade Act is nearing \$1M.

Education paths include CNC, welding, HVAC, continuing education, CDL A licenses, chef, and business.

Herkimer office is open by appointment. Remington takes up about 95% of time, County staff is able to handle other customer needs Great job Karin!!

Replacement was found in-house, Stephanie Heiland who worked on the Criminal Justice for Youth program has been working with Rochelle to get caught up. Lot of activity on WANTO grant.

### **Center Update**

#### Rome

Terry from Rome Center said they've had a constant flow of customers via phone or virtually, still not open to public. Some customers have challenges with no e-mail or scanner but they are working around that, meeting people at door to receive or hand out forms, mailing forms. They have 22 from Remington that are in school. The deadline to enroll in training through the Trace Act deadline is April 2.

Business Services staff working with employer needs, seeing a boost in wages, manufacturing up \$2-\$3 an hour.

Samantha DiRiso asked both Terry and Karin to send her information to push out to Remington folks regarding deadline. Karin said they sent out another mailer and that helped.

### Utica

Cheryl from Utica Center said the DOL staff has been dedicated to pandemic response, significant UI fraud, staff was assigned to that 7 days a week, overnight hours. Finally mostly back down to 5 days a week, hard work but rewarding. Missy said still doing virtual services but mostly all pandemic related.

#### Oneida

Ellen said majority of calls are for unemployment fraud or still calling to ask how to get their money. No DOL staff, all County by appointment only, they do have a drop box in front. 8 Remington customers, 1 potentially going to school, few waiting to see what's going to happen. She also noticed the salary increases but hard to get people to go back to work with transportation and child care issues. Ellen said 3-4 people call for or apply for openings but don't follow through.

Amy from MVCAA mentioned that the majority requesting assistance are females, head of household with children. They can't return to work due to child care, very frustrated. You can see the difference in UI claims females vs males. 150K women out of work.

Headstart started opening back up a few weeks ago, birth to preschool age.

Phil said to call DSS for help with daycare issues – MVCA makes a lot of referrals to DSS.

Terry is seeing a lot of interested in tele jobs, mainly medical billing. Is there a skills gap? Need further conversation. Will see a shift in how employers will operate more toward tele jobs.

### Other business

MVCC Job Corp expanded beyond zip codes 13501 & 13502 to include from any community in Mohawk Valley. Available for ages 17-24, low income, must be US citizen or permanent resident. 1 year certificate in mechatronics, welding, cnc machinist, carpentry & masonry and HVAC. Funding pays for student tuition, books and supplies as well as some meals and transportation cost. Julie sent the flyer on 3/12.
